SUMMARY DESCRIPTION OF BUSINESS

What is our business?

EDM is a Canadian exploration and mining company that has full ownership of the Scotia Mine and related facilities near Halifax, Nova Scotia.

EDM's Scotia Mine is a brownfield critical minerals operation, on high level care and maintenance, with permits in place for the majority of its 14-year mine life to extract Zinc, Lead and Gypsum products. For more information on the Scotia Mine, please refer to the 2021 Pre-Feasibility Study, titled "Scotia Mine Pre-Feasibility Technical Report", prepared for the Company by MineTech International Limited and dated November 16, 2021, which is available under the Company's profile at www.sedar.com.

EDM also owns 100% interests in several prospective exploration prospects near the Scotia Mine and in the surrounding regions of Nova Scotia.

Recent developments

There are no material recent developments in respect of the Company that have not been disclosed in this offering document or in any other document filed by the Company in the 12 months preceding the date of this offering document.

Material facts

There are no material facts about the securities being distributed that have not been disclosed in this offering document or in any other document filed by the Company in the 12 months preceding the date of this offering document.

What are the business objectives that we expect to accomplish using the available funds?

The Company intends to use the net proceeds from the sale of HD Shares to advance geotechnical and environmental bonding work at its wholly-owned Scotia Mine located 60 km north of Halifax (the "**Scotia Mine**"), to pay deposits for long-lead time equipment required to commence mining operations at the Scotia Mine, and for general working capital purposes over a period of 12 months following closing of the Offering.

The Company intends to use the gross proceeds from the sale of FT Shares to incur Qualifying Expenditures related to the Company's exploration prospects in Nova Scotia, on or before December 31, 2023. This includes programs and expenditures to carry out field work on its Carrols Corner/Farm, Eastville and Enon/Loch Lomond prospects (the "**Prospects**") in order to develop drill targets through surficial work and geophysics. The Company expects such activities will be carried out over a period of 9 months following the closing of the Offering.
